STATE HOUSING INITIATIVE PARTNERSHIP PROGRAM 25/26

THE CITY OF TITUSVILLE ANTICIPATES RECEIVING STATE GRANT FUNDS OF APPROXIMATELY **\$387,167** FROM THE FLORIDA STATE HOUSING INITIATIVE PARTNERSHIP (SHIP) GRANT PROGRAM, FOR STATE FISCAL YEAR 2025/2026, EFFECTIVE JULY 1, 2025, FOR THE FOLLOWING PROGRAMS:

Rehabilitation Program- repairs to owner-occupied single-family residences

Weatherization Program- exterior improvements to owner-occupied single-family residences

First Time Homebuyer Program- purchase assistance for new or existing single-family homes

Rental Rehab – repairs to affordable housing rental units for non-profit property owners

STARTING JULY 1, 2025, APPLICATIONS WILL BE ACCEPTED FOR THESE PROGRAMS. ALL APPLICANTS WILL BE PLACED ON A PROGRAM WAITING LIST, WITH THE EXCEPTION OF THE FIRST-TIME HOMEBUYER PROGRAM AND RENTAL REHAB, IN THE ORDER IN WHICH THEIR APPLICATION IS RECEIVED, AND SELECTED AND ASSISTED ON A FIRST-QUALIFIED, FIRST-SERVED BASIS. APPLICANTS AND PROPERTIES ASSISTED THROUGH THE ABOVE-PROGRAMS MUST BE LOCATED WITHIN THE CITY LIMITS OF TITUSVILLE AND HOUSEHOLDS MUST MEET INCOME ELIGIBILITY GUIDELINES FOR LOW-INCOME HOUSEHOLDS. PRIORITY ASSISTANCE IS GIVEN TO THE FOLLOWING GROUPS IN THE FOLLOWING ORDER:

- HOMEOWNERS WITH EMERGENCY CONDITIONS IN THEIR HOME, WHICH REPRESENT A THREAT TO THEIR HEALTH AND SAFETY
- PERSONS WITH SPECIAL NEEDS OR WHO HAVE A DEVELOPMENT DISABILITY as defined by FS 420.0004(13) and 393.063(g)
- ALL OTHER APPLICANTS SERVED FOR THE FIRST TIME
