

**PUBLIC NOTICE CITY OF TITUSVILLE**  
**STATE HOUSING INITIATIVES PARTNERSHIP (S.H.I.P.) PROGRAM**  
**LOCAL HOUSING ASSISTANCE PLAN (LHAP) AMENDMENT #2**

PURSUANT TO SECTION 420.907 THROUGH SECTION 420.9079, *FLORIDA STATUTES*, AS AMENDED, AND RULE 67-37, *FLORIDA ADMINISTRATIVE CODE*, AS AMENDED, THE CITY OF TITUSVILLE HEREBY GIVES NOTICE OF ITS PROPOSED AMENDMENT TO THE CITY'S STATE HOUSING INITIATIVES PARTNERSHIP PROGRAM (S.H.I.P.) LOCAL HOUSING ASSISTANCE PLAN (LHAP) FOR STATE FISCAL YEARS 2022-2023, 2023-2024, AND 2024-2025. THE AMENDMENT CHANGES AN EXISTING STRATEGY FROM A FEE ASSISTANCE STRATEGY TO A NEW CONSTRUCTION STRATEGY ALLOWING FOR CONSTRUCTION SUBSIDY VERSUS ONLY FEES, FOR AFFORDABLE RENTAL HOUSING OPPORTUNITIES TO INCOME ELIGIBLE PERSONS. CITY COUNCIL WILL TAKE ACTION ON THE LHAP AMENDMENT ON TUESDAY, FEBRUARY 24, 2026 DURING ITS REGULAR MEETING IN THE COUNCIL CHAMBERS, CITY HALL, 2<sup>ND</sup> FLOOR, 555 S. WASHINGTON AVENUE, TITUSVILLE AT 6:30 P.M. ALL CITIZENS ARE INVITED AND ENCOURAGED TO ATTEND THIS MEETING AND MAKE ORAL OR WRITTEN COMMENTS REGARDING THE PLAN AMENDMENT.
